7	By-election to be held in Northampton next month - People living in West Northamptonshire Council's East Hunsbury and Shelfleys electoral ward will be able to go to the polls on Thursday, 8 February to vote for a new councillor to represent their area. The election was prompted by a vacancy following the resignation of former WNC Councillor Suresh Patel. More information can be found at <b>Electoral services</b>		
8.	The road sign at Nobottle was apparently cleaned but they didn't do both sides so this has been reported again.		
9.	Members of West Northamptonshire Council's (WNC) Taxi and General Licensing Committee will consider whether to approve a new draft policy designed to protect taxi and private hire passengers. The draft policy's key aim is to ensure that drivers and vehicles meet high standards in protecting the public and providing a quality service. It has been through extensive consultation in recent months with many opportunities for the everyone, including the industry, to submit comments. More details at <u>Taxi and Private Hire Draft Policy</u>		
10.	Althorp Estate have advised that they understand a payment made in March 2022 for rent had not been received although this was minuted at the time; Cllr Milne indicated he would investigate the Bank Statements at the time and advise.		

•	Flooding – Due to storm Hawk our agencies have been very active over the last few days. Kier have attended
	245 incidents across our area relating to roads and trees. We also co-ordinated the evacuation of 2300 people at Billing Aquadrome.
•	Consultation season – there are numerous consultations currently in progress and would encourage individual Councillors to have their say.
	1 Budget for 2024/5 – this is open until 23rd Jan before final budget goes to Cabinet 22nd Feb
•	Review of Parish arrangements – again a chance to have your say on the range of proposals on the table, ranging from boundaries, number of Councillors and dissolving parish meetings.
•	A new online directory of services for children and young people in WN with special educational needs and disabilities (SEND) has been launched. The local offer website is a user-friendly online platform that brings together a range of information about services available. There is also communities online in Instagram, Facebook and X.
•	A new draft policy for Taxi services will be considered this week (w/c 15/01/23) to protect taxi and private hire passengers. This draft policy has already been through extensive consultation and should ensure passengers have a positive experience. In addition to this Taxi Marshalls patrol taxi rank in Northampton at weekends to again ensure safety of passengers.
•	The Pothole Pro machine which was acquired by WNC has recently entered service recently. This machine supplied by JCB is designed to repair potholes in 8 mins and will be used on roads in WNC. Its design delivers a "unique three in one solution" which reduces the number of staff needed for the job. The machine has teeth which breaks up existing surface and waste is swept away into a bucket. It then cuts back any edges so when material is laid it's got a nice flat edge to seal the surface back to.
